## Payment Terms

## Extra Fees

- Carpark fees, entry fees or deposits required by the management at a private venue shall be paid for by the client(s). (Client are to check with management on the terms regarding engaging of swim coach)

## Withdrawal

- Any remaining credit not consumed will be forfeited.

## Refund

- There will be **no refund** of fees if package expires with unused credits.

- There will be **no transferring** of fees from 1 registered student to another even under the same client.

## **5<sup>th</sup> Week**

- There will be no regular lessons on the 29<sup>th</sup> / 30<sup>th</sup> / 31<sup>st</sup> of each month.
- Replacement class can be arranged subject to Coach's availability.

## **Public Holiday (PH)**

- If lesson day falls on a PH, there will be no class (Package validity will be extended by a week).

## **Holiday**

- There will not be any class on first 2 weeks of June and last 2 weeks of December, any

class that falls within these periods will be eligible for package extension.

## **Inclement Weather**

- Client will be required to inform coach of bad weather or expected bad weather at least 30 mins or more before commencement time of class or lesson will be conducted.
- Class can be rescheduled (subjected to coach's availability) if informed promptly.

## **Absence / Holiday**

- Lesson will be considered conducted for student(s) if coach has arrived at venue.  
**\*Last minute cancellation is not allowed\***
- Pro-rate / Replacement class / Time extension will not be given for any absence.

## **Cancellation**

- No fee will be charged; fees will be pro-rated if class is cancelled by coach due to unforeseen circumstances.
- Replacement class will be conducted if agree-able with client(s) for the class cancelled by coach.

## **Medical Condition**

- Client will truthfully declare any allergies / medical / developmental / behavioral condition during registration.
- Student(s) will be withdrawn if deemed unsuitable for class.

## **Media Rights**

- Videos / Photographs will be taken during class for the purpose of training / advertisement.

## **Indemnity Clause**
